expenses, commercial general liability insurance on the

Gainesville Chinese School (GCS) offers a unique program for anyone who is interested in Chinese language and culture. Mandarin, traditional Chinese characters and conversational skills are taught. In addition, aspects of Chinese culture, such as poetry, calligraphy, brush painting, folk dances, crafts and Chinese martial arts are introduced.

Classes are held most Sunday afternoons during the school year. The class is a rigorously structured language course. In this program, students progress from the beginner's level to the advanced levels through years of study. Applicants with or without previous learning of Chinese are welcome. Each student is individually evaluated to determine his/her level of expertise and placed in an appropriate class.

Periodically the GCS holds seminars for its students and their parents. These seminars foster a friendly setting for discussions relating to the Chinese classes.
